Financials

Bill Higginson briefly discussed the CPTC Foundation's quarterly financial report showing the actual revenue and expenditures through July 31, 2022. Foundation Trustees were sent a copy of the financial report in the CPTC Foundation drop box, and a printed copy was on hand at the meeting. As of July 31, 2022, the financial report shows as a total of \$2,022,742.04 in assets. The profit and loss statement for January 2022 through July 31, 2022, shows a net loss of \$135,412.52. Looking at the Profit and Loss Statement for the month of July 2022 only, the Foundation has a net income of \$42,203.98.

Upon a motion to approve by Judge Kelly Brooks, a second by Donna Poe, the CPTC Foundation unanimously approved the financial reports as presented.
