## CABINET REPORTS (Full reports uploaded to Dropbox seven (7) days prior to meeting.) Office of Academic Affairs – Amanda Morris

The Surgical Technology's bid for the lab operating room to receive a new boom with operating lights, monitors, and endoscopy equipment to replace the outdated equipment has been accepted installation is being scheduled.

The Automotive and Auto Collision programs are working together to host a car show September 23 on the Waycross Campus.

Kimberly Burgess, Apprenticeship Coordinator, worked with Nate Cason, Marketing Specialist, to create a video testimonial for Jered/PaR Marine in Brunswick, Georgia to highlight Jered/PaR Marine's experience with the apprenticeship program. The College will use this as a recruitment tool for more businesses that are considering an apprenticeship program with CPTC.

## Office of Administrative Services – Angie Crews

Board members received a handout of the College's budget report showing the actual year-to-date revenue and expenditures for the College.

#### Office of Adult Education - Katrena Felder

GALIS Report #AE095, WIOA Table 4, displays the WIOA local totals of the number of students enrolled, total attendance hours, MSG, separated, remaining, and percentages by entering educational functioning level for all POPs (Periods of Participation) for FY23 in Adult Education (AE):

- Total Enrolled Students Educational Functioning Level ABE Levels 1-5 students: 613
- Total Enrolled Students Educational Functioning ESL Levels 1-5: 616
- Total Number of Students Enrolled for both ABE & ESL: 674
- Total Hours of Attendance both ABE & ESL students: 36,750
- Total Percentage of ABE students who achieved a MSG: 121 = 37.68%
- Total Percentage of ESOL students who achieved a MSG: 13 = 21.31%
- Total Number of I.E.T. Workplace Literacy Participants who achieved a certificate: 4
- Total HSE's(GED or HISET Diploma) earned for current FY23 year: 106

The FY23 MSG% negotiated state performance target has been set at 45%. CPTC's FY23 current MSG % is 35.88%.

## Office of College Advancement – Lauralee Beauregard

Lauralee Beauregard, CPTC Marketing Coordinator, presented on behalf of Stephanie Roberts.

Thus far, the CPTC Foundation has awarded \$16,000 in scholarships for the Summer semester.

The CPTC Foundation received \$25,000 from the Georgia Department of Natural Resources for the Commercial Fishing Scholarship.

#### Office of Economic Development – Dr. Pete Snell

The Georgia Department of Corrections' budget for FY23 training has been depleted. Plans are to submit a training schedule for all four prisons that alternate between OSHA 10 and ServSafe every other month for August through May (FY24).

## Office of Facilities - Chad Boyett

The footers have been poured, plumbing rough-in is complete, and the columns have been poured for the new Precision Machining & Manufacturing building on the Camden Instructional Site. Estimated completion date is currently set for November 13, 2023. The College expects to start serving students in the new building Spring Semester 2024.

Progress continues on the Southern Pines Career Academy building with material completion expected August 20, 2023. Plans are to begin teaching classes in the new facility Fall semester 2023.

#### Office of Institutional Effectiveness – Vince Jackson

Vince Jackson is developing the Perkins budget for FY2024. The allocation for FY2024 is \$703,506.00 with a \$55,000.00 rural reserve for a total of \$758,506.00. The current un-allocated amount is \$205,370.00.

## Office of Police & Security – Ethan Johnson

CPTC Campus Police Chief, Ethan Johnson, and the CPTC Safety Committee began conducting safety inspections of the College's campus and instructional sites during the week of May 1-5. Thus far, only a few minor issues, such as light bulbs being out, were found.

#### Office of Special Projects – Eva Byrd

CPTC will be hosting the Summer Internship on the Waycross campus June 5-29, 2023. This internship provides an opportunity for students to gain a college credit and get some work experience for their resumes. The College has 20 students confirmed to participate, with another 33 who applied/inquired. Students confirmed include:

#### Office of Student Affairs - Karla Nordone
