# CABINET REPORTS (Full reports uploaded to Dropbox seven (7) days prior to meeting.) Office of Academic Affairs – Karen Scott

The Paramedicine Program's accreditation report for the 2021 reporting year has been approved by the Committee on Accreditation of Education Programs for the Emergency Medical Services Professions (CoAEMSP). The CoAEMSP accreditation site visit is scheduled for October 2-3, 2023.

The CPTC Stingray Car show is scheduled for Saturday, September 23 on the Waycross Campus from 8:00 a.m. until 12:00 p.m. The event is open to the public and everyone is invited to attend.

Board members received a handout of the College's budget report showing the actual year-to-date revenue and expenditures for the College.

#### Office of College Advancement – Stephanie Roberts

The AT&T Digital Divide Grant of \$25,000 was awarded to the Technical College Foundation Association (TCFA). The grant will be split between CPTC, Wiregrass Technical College and Southern Regional Technical College to develop a lending library.

The Charles B. Eames Travel Scholarship Luncheon is scheduled for October 11, 2023, on the Jesup Instructional Site.

#### Office of Economic Development – Dr. Pete Snell

Dr. Pete Snell, in conjunction with the Technical College System of Georgia's (TCSG) Economic Development Division has developed an Economic Development Leadership Training (EDLT) that will begin as a bootcamp style of training (condensed and fast-paced) and has a focus on TCSG Economic Development operations. It will consist of one afternoon and one morning, for a total of eight hours of training and will be held annually.

Approximately 70% of TCSG's VPEDs are less than five years old, and this includes two years during the pandemic. Consequently, the first session will only be for current TCSG VPEDs. Future sessions will be open to new and potential future VPEDs, along with staff who may also benefit. Future new VPEDs will also be assigned to a more senior VPED mentor.

The inaugural annual EDLT training was held Aug 29-30, 2023, at Central Georgia Technical College in Warner Robins. Despite being cut short due to Hurricane Idalia, the training was a huge success.

### Office of Student Affairs - Karla Nordone

As of September 6, the College has 3,992 students registered for Fall semester. Enrollment for Fall 2023 was 3,746. Traditional Enrollment consists of 1,671 students or 41.9% while Dual Enrollment with 2,321 students make up the remaining 58.1%.

CPTC had approximately 120 students who successfully submitted applications and utilized the fee waiver code provided for Free Application Week.

## **President's Budget Presentation – Lonnie Roberts**

Lonnie Roberts, CPTC President, presented the College's FY24 budget (\$26,859,492) and reviewed the Technical College System of Georgia's budget request for FY2025. Board members also received a handout of this information.
